

ANVESANA Innovation and Entrepreneurial Forum, hosted at PES Trusts' PES Institute of Technology and Management (PESITM) in Shivamogga, has been selected under the state government's flagship Technology Business Incubator (TBI) 2.0 Mission. "This prestigious honour brings a funding support of Rs 10 crore, aimed at accelerating innovation and entrepreneurship in Tier-2 and Tier-3 regions," Anvesana stated. As part of the 'Beyond Ben-

galuru' initiative, this strategic allocation seeks to decentralize innovation ecosystems by fostering grassroots entrepreneurship outside the state capital. Anvesana TBI will focus on emerging sectors integral to the Malnad region, including AgriTech, Tourism, Health-care, and Education.

"Since its inception, Anvesa-na has played a vital role in nurturing innovation by providing early-stage startups with robust support through mentorship, collaborative learning, and essential resources. Its vision is to empower rural and semi-urban entrepreneurs by supporting their

journey from ideation to com-mercialization, offering incubation facilities, seed funding, technical guidance, and connections to markets and investors," Anvesana added.

Anvesana said that the Rs 10 crore grant/will enhance the incubator's capacity to support more innovators and startups by expanding access to advanced infrastructure, domain expertise, and prototyping ca-pabilities. Under the guidance of the Department of IT, BT & S&T. Government of Karnataka, 11 new Technology Busi-ness Incubators have been launched statewide under LEAP (Local Economy Accelerator Program) to promote local entrepreneurship




>>> PRICING STRATEGIES THAT WIN: INSIGHTS FROM MR. MARMIK, BLUME VENTURES






>>> AUGUST MONTH MENTORSHIP HIGHLIGHTS AT ANVESANA


